

- On February 22, 2012, training for the EPIC Project began with a Master Training Session (Train the Trainer) hosted by the EPIC Education team. Master Trainers were selected to disseminate and train the Arizona EMS system on the EPIC Project .
- We are proud that the EPIC team and EPIC Master Trainers have trained 1,074 EMS personnel in Arizona. Our goal is to train the entire EMS community of approximately 18,000 EMS providers by the end of 2012.

TBI Clinical Pearls

- The EMT-V (the person providing ventilation) compare this key person to the "compressor" in "Minimally Interrupted Cardiac Resuscitation" (MICR) or Cardiocerebral Resuscitation (CCR). This provider has <u>the most important</u> job and must be very focused on administering the appropriate number and volume of ventilations to increase the chance of survival and good neurological outcome. Remember, the EMT-V concept will benefit any intubated patient, not just TBI patients.
- Exercise *extreme caution* with administration of drugs that can potentially lower blood pressure (i.e, opiates, benzodiazepines) when caring for TBI victims as hypotension can dramatically worsen outcome.
